Age Care

Westonia Home Care Services now has a total of 17 clients which is quite incredible, EOI to any community members wishing to obtain their Certificate 3 in Aged Care has been advertised in the Westonian, this is to encourage a more qualified local workforce and therefore able to deliver a higher standard of care. Meal preparation can be quite tedious and difficult for some of our clients, Lite N Easy are HCP approved providers of meals which allows each clients package to pay 70% of the fee leaving the client only 30% out of pocket which is a massive saving. We have signed up 6 clients so far who have appreciated this service and the peace of mind knowing the meals are healthy and nutritious.

The service has worked closely with clients and allied health professionals such as Occupational therapist, physio and podiatry, to ensure client needs, equipment and aids are being met and supplied to keep each client safe and assisted in their homes.





Local Government House Trust Update



Background

The Local Government House Trust ("the Trust") is a unit trust created in 1980 to provide building accommodation to the Western Australian Local Government Association (WALGA)

Under the current Trust Deed, 132 Local Governments made financial contributions to create a Trust comprising 620 units. Units are of equal value and are revalued annually once the Board of Management adopts the audited Financial Report at its November meeting.

People and Culture team support and deliver all things employee related. The team's role is to build the capability of all employees by delivering frameworks and strategies that enable a flexible, sustainable, and equitable workplace, to encourage all employees to

Since January 2014, the Trust has provided WALGA with accommodation at 170 Railway Parade, West Leederville. The building fulfils an essential requirement to provide suitable accommodation for the Association and its staff while representing a long-term investment opportunity through rental income and long-term capital growth. The building includes meeting rooms used extensively for training courses provided to Elected Members and Local Government officers and meetings of WALGA's State Council, its committees and various policy groups and committees. Meeting rooms are also available for use by members.

Additional Information about the Trust

Trust Deed 1993 provides a completion date for the Trust of 2072. The average cost of units issued is \$1,050.

The current Trust Deed makes no provision for the withdrawal of units, which may reflect the donation nature of the original transactions, while avoiding undermining continuity for a long-term asset.

170 Railway Parade Building

The building at 170 Railway Parade, West Leederville, consists of four levels of quality office space. WALGA leases level one, enabling WALGA employees to be housed on a single floor. Three levels are available to third-party tenants, with additional rental space on the ground floor occupied by an all-day childcare centre and café. Underground building car parking ensures sufficient parking for visitors.

The energy-efficient building uses solar power generation from PVC Units and carries a 5 Star Green Star rating and achieved an indicative five-star NABERS rating for energy and water. Located close to the Mitchell Freeway and Leederville Station, the building is conveniently situated.

Building Ownership

The Trust has 60 per cent ownership of 170 Railway Parade through its joint venture with Qube Property. While the JV agreement ends in 2024, the Board of Management has been exploring the feasibility of outright ownership since 2022. (more details below)

Board of Management

The Trust is overseen by a Board of Management:

- WALGA President who acts as the Chairperson of the Committee
- Deputy President who acts as the Deputy Chairperson
- A State Councillor representative from the Country Constituency
- A State Councillor representative from the Metropolitan Constituency
- A representative from the beneficiaries in the Country Constituency
- A representative from the beneficiaries in the Metropolitan Constituency, and
- The WALGA Chief Executive Officer.

Highlights from 2022-23


- 170 Railway Parade building continued to be fully tenanted
- The building's weighted average lease expiry (WALE) was 4.1 years at 30 June 2023
- Trust's cash reserves grew to \$5.8 million as of 30 June 2023
- Building loan debt held by the Joint Venture was \$24.4 million on 30 June 2023 (Trust's 60 per cent share of the loan being \$14.64 million)
- Loan/Valuation ratio of 47.3% sits comfortably below Bankwest's maximum of 63 percent
- The lease agreement held by LGIS for levels two and three was successfully extended until 30 June 2027 with further options, and
- The building cladding was upgraded to cladding of the highest fire rating.

House Trust Unit Value

The unit value as at 30 June 2023 is \$20,793 representing an annual increase of 2 per cent. Unit values follow the movement of the Trust's Net Assets, which at 30 June 2023 is based on \$12,891,481 over 620 units. The Trust's Net Assets include the Trust's 60 per cent share of assets and liabilities held by the Joint Venture. It should be noted that the above unit value is based upon the historical cost of the building less accounting depreciation.

Below is a graph illustrating the recent trends in unit values which reflect the movement in net assets.

Key drivers include occupancy, commercial lease income rates and interest on loan debt. The downward fluctuation between 2014 and 2016 relates to the transition from the previous building to the current at 170 Railway Parade, West Leederville. The uplift in 2018 is due to the restatement of net assets following the change in accounting for lease income to the straight-line basis from the previous "as an invoiced basis". Growth in net assets and unit price of the Trust between 2018 and 2022 is due to full tenancy and record low interest rates. Recent increases to interest rates and cladding replacement resulted in a reduced increase in 2023.



Financial Analysis and Outlook

The House Trust's outlook remains positive, with full tenancy continuing, supported by the LGIS/Marsh lease extension. After many years assisted by record low interest rates and full occupancy, the House Trust demonstrated its resilience by recording a profit despite increased interest expense on the building loan. The 2023-24 year sees a further tightening with the anticipated downward alignment of lease income from levels two and three leases to current commercial lease rates. Current interest rates are currently expected by the RBA to persist until late 2025. With Perth's population forecast to grow to 3.5 million by 2050, the medium and long-term prospects for the Perth commercial property market remain positive.

Outright building purchase in 2024

Under the Joint venture agreement, the House Trust has a one-off opportunity at the 10year point of the agreement to buyout Qube's 40 per cent stake in the building during the 2024 year. Benefits include greater strategic control of the building and the opportunity to pursue a strategy of a debt-free building. Financial modelling and advice from independent property consultants support the feasibility of the outright purchase. Projections show that surplus cash will fund the reduction of the building loan while providing a buffer against higher interest rates and future potential vacancies. Financing of the buyout will be from a mix of House Trust Cash Reserves and additional loan debt. The buyout decision will be considered by the Local Government Houst Trust's Board of Management and WALGA's State Council in late March 2024. The acquisition transaction would occur in July and would have no impact upon unit holders.

TIME TO TAKE CONNECTIVITY IN THE BUSH SERIOUSLY

22 January 2024

Happy New Year! How was your start to 2024?

Out here in the Wheatbelt we've been experiencing some scorching days and nights. That's nothing new, and we expect it at this time of the year. Hot, dusty, with a few summer storms thrown in for good measure.

The storm that came through last week was a ripper. I sat inside my 100-year-old house and watched mother nature let loose with a spectacular light show, thunderclaps that reverberated through your body, and rain and wind that arrived with a ferocity that twisted trees in half and ripped roofs off sheds and houses.

I was one of the lucky ones, no damage, and no power loss. Unfortunately, many were not so lucky, and have endured days of no power, limited water, and a clean-up in the stifling heat.

As always, everyone has pitched in to help, neighbours checked-in on each other, and people called on the elderly for a chat. Our Shire Council's opened their offices or recreation centres when they had the generator hooked up for respite from the heat and so people could charge their phones.

We accept that mother nature can be fickle, and for the most part we take care of ourselves. Moving on and people have cleaned out freezers of spoiled food, doctors are checking vaccines and drugs that may have spoiled, and businesses are counting the lost days of trade. The Government's \$240 extended blackout payment will barely touch the sides for many.

A call round to the 27 local Governments in my electorate has come back with a resounding theme. The first, a heartfelt thank you to the Western Power and Water Corporation workers who have been on the tools getting things back on track. The second, that telecommunications and connectivity during and after these events remains an absolute disgrace.

More than a week after the event, there are still communities in a cone of silence. They can't even call 000. And had they been able to, no-one could despatch first responders because they receive the call-out via the mobile network.

How is it in this day and age we still have this problem?

Inquiry after inquiry, report after report, with multiple recommendations highlighting the fact that telecommunications is an essential service that fails our communities when they need it the most.

What will it take for the Federal and State Governments, and the telecommunications companies to take this seriously? A serious injury? A death? That is what my constituents ask. They are frustrated beyond belief.

And the salt is ground into the wound when they hear representatives from telco's pointing the finger at Western Power for the failures, and Government Minister's passing the buck right back.

After the bushfires over east, Cyclone Seroja in 2021, and the fires in Esperance and through my electorate at the beginning of last year, there has been a consistent gap in our preparedness to respond to natural disaster because of failures to build resilience into our telecommunications infrastructure.

I'm not letting the State Government off the hook for their woeful track record dealing with power infrastructure in the bush – that needs to be addressed, and urgently. It's a scandal that we have billions sitting in State coffers while basic infrastructure fails those of us that chose to live or work outside of Perth.

But the telecommunications issue must be dealt with first. It is vital that people can communicate with each other at all times in the case of emergencies.

Every three years, a Regional Telecommunications Independent Review Committee is formed to conduct a review into the adequacy of telecommunications in regional, rural, and remote parts of Australia.

Last conducted in 2021, it recommended that the Universal Service Obligation (USO) required of Telstra for the maintenance of the copper wire network be reformed to become 'technology agnostic' and require the inclusion of backup power and stringent minimum availability and voice quality standards, enforceable through significant penalties.

The reviewers also observed that mobile base stations, telephone exchanges and other key infrastructure are vulnerable to interruptions to the power network and have insufficient back-up power to maintain critical communications services during extended power outages.

Why do we still have these problems when taxpayers fork out in excess of \$335 million per every year to Telstra as part of their USO to deliver services. And why did the Albanese Government delay investment in the Mobile Network Hardening Program announced in 2022 to increase battery back-up and create generator hubs for rapid deployment to telco sites? According to the website Round 1 is only 60 percent complete two years later.

People who live in these communities deserve better, as do the many that visit, work and pass through the Wheatbelt.

It's time for the buck-passing and poor excuses to end. We need the State and Federal Labor Governments to step up and take this seriously.

WALGA's 2024-25 State Budget Priorities

In this guarter WALGA prepared and released its 2024-25 State Budget Submission, which calls for further investment in infrastructure and services to meet the needs of communities and to improve safety.

WALGA President Cr Karen Chappel AM provided WALGA's submission to the newly appointed Minister for Local Government Hannah Beazley BA MLA when they met prior to Christmas.

"Western Australia has a strong financial position, and the upcoming State Budget presents an important opportunity to provide support for programs that will deliver a benefit to the community over the long term," President Chappel said.

"Many of the initiatives set out in WALGA's State Budget Submission will help with this task."

Local Government Elections

Voter turnout for the 2023 Local Government election was 31.6%, which was an increase on the 2021 election which was 30.20% so an increase of 1.4% The reforms to the Local Government Act, including changes to wards, councillors' number and popularly elected Mayors/Presidents has seen a reduction in councillors numbers to 1137.

Of the current elected members, 40% are female and 60% male. Of the 263 newly elected members (not re-elected), 43% are female.

Of the 15 in person elections held, 9 were elected unopposed, another had 4 out of 4 offices elected unopposed (1 will go to extraordinary), another had 4 offices elected unopposed (2 will go to extraordinary). 4 in person's went to full elections.



Regional Road Group Report

February 2024

Roads

Local Government Transport and Roads Research and Innovation Program (LGTRRIP)

Four new projects have been initiated as part of the Local Government Transport and Roads Research and Innovation Program:

- 1. Use of crumbed rubber modified bitumen and reclaimed asphalt (RAP) in asphalt applications,
- 2. Use of crumbed rubber modified bitumen in spayed seal applications,
- 3. Design and construction guidance for the use of crushed recycled concrete, and
- 4. A catalogue of typical pavement structures for local roads.

This program of work builds on the projects completed in 2023.

Condition Assessment of Roads of Regional Significance

Industry proposals were assessed and a consultant appointed to complete a road condition assessment for all *Roads of Regional Significance* in the South West region of WA (approximately 2,100km). The project commenced in January 2024 with the bulk of the survey work to be performed between February and April 2024.

Road Rail Interface Agreements

Rail Interface Agreements are a requirement under the *Rail Safety National Law (WA) Act 2015*. A model *pro forma* agreement between Local Governments and Arc Infrastructure is nearing the end of negotiations and should be available for Local Government review and action soon. This agreement updates various elements of the existing agreements, particularly adding clarification on types of works and the responsibilities of both parties. As soon as this is complete, WALGA will liaise with each affected Local Government to provide advice around the new agreement.

Funding

State Road Funds to Local Government Agreement 2023/24 – 2027/28

Working groups have been established to progress implementation of the commitments made in the agreement in relation to:

- 1. Increasing application of the Safe System approach to the local road network,
- 2. Employment of Aboriginal people, and
- 3. Use of recycled materials in road construction and maintenance.

Each of these groups has held at least one meeting during the quarter.

Roads to Recovery and other Federal Funding Programs

Working with ALGA and the State Associations, WALGA engaged with the Department of Infrastructure, Transport, Regional Development, Communications and the Arts concerning the design and guidelines for key Australian Government infrastructure funding programs, Roads to Recovery, Black Spot and the Safer Local Roads & Infrastructure Program. WA Local Governments are generally supportive of the administrative arrangements. The competitive funding approach for the smaller programs raises equity concerns, as a reasonable level of resources is required to develop strong project proposals.



Multi-Criteria Assessment (MCA) Model Revisions

Work continues to harmonise the MCA models used by Regional Road Groups to prioritise project proposals for funding under the Road Project Grant funding pool. The process has now commenced in seven of the nine regions in regional WA. The proposed changes to the MCA models reflect the new focus areas of the State Roads Funds to Local Governments Agreement, while still allowing for flexibility to recognise the significant differences between regions.

Business Case for Safety Improvement to High Speed Sealed Local Government Roads

Meetings were held with the Minister for Road Safety / Minister Assisting the Minister for Transport and senior government officers concerning the proposed investment by Federal and State Governments to improve the level of safety provided to users of high speed, sealed Local Government roads in peri-urban and rural areas. The Association is continuing to work in partnership with the RAC to highlight the importance of this investment.

WALGA's RoadWise Councils initiative is a fresh approach aimed at engaging and supporting Local Governments to adopt and apply policies and practices that effectively and sustainably lead to better road safety outcomes for WA communities.

Since invitations to participate commenced in August 2023, fifty-four (54) Local Governments have registered as a RoadWise Council. The majority (70%) registered with a resolution of full Council and thirty percent via a Declaration signed by the Shire President/Mayor and the Chief Executive Officer.

Participating Local Governments are spread across the state with RoadWise Councils located in all ten Regional Road Group regions.

In terms of road safety activities, 37 or 71% of registered RoadWise Council have recorded the delivery of activity aligned with the RoadWise Council Framework in the first few months.

Local Government Aquatic Water Sampling Exemption – Westonia Aquatic Centre – 128 Diorite Street, Westonia – Shire of Westonia

I refer to your application received on the 15th December 2023, seeking an exemption for the Shire's Environmental Health Officer (EHO) from collecting water samples at the above aquatic facility in accordance with section 21 of the *Health (Aquatic Facilities) Regulations 2007* (Regulations).

It is acknowledged that due to the EHO's current schedule and distance of Westonia Aquatic Centre from the nearest water testing facility that it is impractical for a local government to comply with this regulatory requirement.

In consideration of the circumstances, I am prepared to exempt the Shire of Westonia EHO from water sampling for the abovementioned aquatic facility in accordance with *subregulation 21(4)* of the Regulations, provided that following conditions are met:

- The Shire of Westonia's EHO is to ensure that the pool manager/person taking samples is deemed competent prior to collecting samples independently;
- The aquatic facility operator must ensure that that water samples are taken at least once per month;
- That the other requirements of *subregulation 21(1)* are complied with;

This exemption is subject to review and may be revoked if circumstances for issuing the exemption change or where the operator has not ensured the required monthly sampling has occurred in accordance with *subregulation 21(5)*.




