

TENDER 3 25/26 – WHEEL LOADER CONDITIONS OF TENDER

1. Lodgement of Tender

Tenders are to be submitted to:

The Chief Executive Officer Shire of Westonia Wolfram Street Westonia WA 6423

and are to be lodged in the Tender Box at the Shire Office in Wolfram St Westonia no later than 4.00 pm on Tuesday 9th September 2025.

Tenders are to be submitted in a sealed envelope marked with the item/s being tendered for. It is the responsibility of the tenderer to ensure that tender documents are lodged in the tender box if delivery is affected by mail or courier.

Late tenders will not be accepted.

2. Opening and Registration of Tenders

All tenders lodged before closing time will be opened and registered at the closing date and time as listed. Any tenderer may be present at the opening and record the prices submitted only.

3. Acceptance of Tenders

The lowest or any tender is not necessarily accepted and canvassing of Councillors or staff will disqualify.

Council will award tenders at their Council meeting of Tuesday 17th September 2025. Acceptance of tender will be affected only by written acceptance after the closing date. This tender and written acceptance thereof shall form the binding contract. A Council Work Order Form will be issued for this purpose.

4. Evaluation Criteria

As part of its evaluation criteria, Council will take into consideration the following:

- (a) Past and present mechanical performances of equipment purchased by Council
- (b) Spare parts availability
- (c) Back up service
- (d) Resale value
- (e) Applicable OHS standards

5. Delivery

The successful tenderer shall deliver the vehicle to the Shire Depot in Cement St Westonia. All costs associated with delivery to this location are to be incorporated in the price tendered.

6. Payment

Payment shall be made within 30 days from the end of the month of delivery of the purchased item. Cash payments will not be made. Goods and Services Tax is applicable to this tender. The tenderer must specify whether the cost per item is inclusive or exclusive of GST.

7. Annulment of Contract

Failure by the contractor to meet the agreed delivery time or any of the technical specifications will constitute grounds for the cancellation of the contract at the discretion of the Shire of Westonia.
