



A letter has been received from the Department of Local Government (attached) advising that the Shire of Westonia did not meet the Departments standard in the area of the Operating Surplus Ratio.

Section 7.12A(4) requires the Shire to report on its future actions to address this result, provide the Minister with this report, and to publish the report on the Council website.

Comment


The Departments own website advises that 110 Councils in WA did not meet the benchmark in the 2017/2018 financial year.

This means that at least 26 metropolitan Local Governments, authorities with far more revenue raising capabilities than Westonia, failed to meet the standard set by the Department.

In the financial year of 2017/2018, the Shire of Westonia recorded an Overall Health Score of 73.1%, placing it in the top 40 Local Governments in the State.

In addition, the Shire has been able to transfer almost \$800,000.00 into its cash backed reserve funds in the current year, representing an outstanding result.

I am advised by several highly experienced and long serving Local Government financial specialists that nobody within the Department is able to clearly explain how the various ratio benchmarks have been established or what relevance they hold.



OFFICER RECOMMENDATIONS

That Council advise the Minister that;

- 1. Current financial reporting requirements have an adverse impact on the ability for Local Governments to meet the benchmark in the area of Operating Surplus Ratio's, and recommend that the Minister address this issue with the Department.
- 2. The Shire of Westonia will continue to pursue excellence in its financial performance through continued diligence in its oversight of the financial management of the Shire.
- 3. Assure the Minister that the Shire of Westonia will continue to develop strategies to secure a long term sustainable future for the community through responsible expenditure management aimed at keeping rate increases to a minimum.

Background

Council has made allowance in its 2019/20 Budget for the purchase of a new Prime Mover to replace the existing Iveco AD500 Stralis. As part of the Budget process, Council resolved to call tenders for the supply of one new Prime Mover.

A notice inviting tenders was advertised on 20 July 2019 with tenders closing on 9 August 2019.

The Shire has been advised of an application for an Exploration licence having been lodged by McMahon Mining Title Services on behalf of Thomas Corr (E77/2613).

The application relates to land in the Warrachuppin area through to Lake Baladjie (Just north of the Mukinbudin-Bullfinch Road) See Attached.

As part of the implementation of the *Public Health Act 2016* (the Public Health Act), the Department of Health (DOH) must review the *Health (Pesticides) Regulations 2011* (the Pesticides Regulations) to examine the risks to public health and safety from commercial uses of pesticides, and discuss options for their management into the future.

As part of the review of the Pesticides Regulations, the DOH must determine whether this public health risk must continue to be regulated under the framework provided by the Public Health Act, or whether the risk can be effectively managed through an alternative approach such as a guideline or other legislation.

The DOH has prepared the discussion paper entitled 'Managing public health risks associated with pesticides in Western Australia' examining three options for Western Australia (WA) for regulating the application of pesticide chemicals:

- **Option A:** Repeal the existing regulations without replacement. Without action, the existing Regulations would be repealed without replacement and individual local government authorities would become responsible for determining pesticide chemical application safety within their jurisdiction. Local government would have the potential to draft and publish local laws to regulate the use of pesticides with their jurisdiction boundary;
- **Option B:** Retention of the existing regulatory regime by making new regulations under the *Public Health Act 2016* identical to those in force under the *Health (Miscellaneous Provisions)Act 1911;*
- **Option** C: Develop new, updated regulations to manage public health risks to uphold the current regulatory requirements including suggested changes in Proposals 7-9 listed below:

Proposal 1: Registration under the new Public Health Act Proposal 2: Licensing under the new Public Health Act Proposal 3: Licensing exemption criteria for individuals Proposal 4: Pesticides in public places Proposal 5: Safe fumigations Proposal 6: Management of registered pesticides Proposal 7: Localgovernment as the enforcement agency Proposal 8: Multi-year validity for registrations and licences

Proposal 9: Introduce substance management plans

Comment

Consultation is now **open** for a 12 **week** period. Local govrnment are encouraged to advise the DOH of their **pr** erred option and **el** to 1dent1fy how these options may present impacts or opportunities for your bcal district. You also have the opportunity to identify alternative options that may not have been

considered as part of this review. This helps to make sure there are no unintended and undesirable consequences, particularly where regulation 1s the preferred option.

SITE

The CBH receival site is located at 11900 Koorda-Bullfinch Road, Warralakin. The Warralakin receival site is located 43km North-West of Westonia. Site entry is accessed via Fox Road, while an exit point exists on Koorda-Bullfinch Road. Existing infrastructure on the site includes a weighbridge, sample hut, two closed storage heads and three open bulk heads. The site also includes staff accommodation quarters and native vegetation (west end).



Comment

The Shire of Westonia does not have a Local Planning Scheme, therefore planning applications shall be consistent with the *Planning and Development (Local Planning Schemes) Regulations 2015* and other relevant State planning policies.

- (w) the history of the site where the development is to be located;
- (x) the impact of the development on the community as a whole notwithstanding the impact of the development on particular individuals;
- (y) any submissions received on the application;
- (za) the comments or submissions received from any authority consulted under clause 66;
- (zb) any other planning consideration the local government considers appropriate.

68. Determination of applications

- (1) The local government must not determine an application for development approval until the later of -
- (a) if the application is advertised under clause 64 the end of each period for making submissions to the local government specified in a notice referred to in clause 64(3); and
- (b) if a copy of the application has been provided to a statutory, public or planning authority under clause 66 the end of each period for providing a memorandum to the local government referred to in clause 66(3).
- (2) The local government may determine an application for development approval by -

- (a) granting development approval without conditions; or
- (b) granting development approval with conditions; or
- (c) refusing to grant development approval.

PLANNING COMMENT

Heritage: The proposed site was adopted to the Municipal Inventory by the State Heritage Council in 1998 (see attachments). The site is considered a Category 3 listing which means the Shire of Westonia is responsible for the preservation of the site.

A category 3 listing is defined as: Retain and conserve if possible: endeavor to conserve the significance of the place through the provisions of the town planning scheme; photographically record the place prior to any major redevelopment or demolition (State Heritage Council 2018).

As the site is of historical significance it is recommended that CBH ensure photographs are taken of the site and sent to the Shire of Westonia as part of this duty.

Traffic: The site contains an entry and exit point. The development application proposes a new exit point for the site which will allow grain trucks to exit the site and turn right only on to Koorda-Bullfinch Road. The proposed traffic route changes provide no significant planning concern.

Visual amenity: It is not believed that the development will impact upon visual amenity in the zone. The development outlined is of a similar nature to that existing on the lot.

Bushfire: The site is in a Bushfire Prone Area. A bushfire management plan has been prepared by Green Start Consulting on behalf of the applicant (see attachments). The management plan outlines a number of recommendations which shall be adhered to via developmental conditions. The Shire of Westonia Fire Break order is relevant to this proposal and shall be adhered to.

General Comment: The upgrades to the site are consistent with the current use of the land. The proposal does not generate any major planning concerns, however Council shall consider the proposed conditions of approval, particularly in relation to bushfire mitigation.

Summary			

Discuss the proposed cartage of gold ore from Marda Dam, Mount Jackson to Westonia via Bullfinch/Warralakin for processing at Edna May Operations, Westonia.

Background

The Chief Executive Officer has spoken to representatives from Ramelius Resources and they will be presenting at the August Council meeting in relation to a proposal to transport gold ore from Marda Dam, Mount Jackson to Westonia via Bullfinch/Warralakin to Ramelius Resources mill (Edna May Operations) in Westonia. The presentation will outline the route times and volume of gold ore to be carted for processing.

Project Description

6 small open pits –including;

- 4 pits at Marda Central Dugite, Python, Dolly Pott & Goldstream
- 1 pit 18km NW of Marda Central –King Brown
- 1 pit 10km SW of Marda Central –Gold Orb

26 mth mining and haulage duration for 1.127Mt of ore

Managed by a small Ramelius management & technical team

Contract mining, no on site ore processing

Contract ore haulage, carting to the Edna May processing plant at Westonia

Proposing to base the ore haulage contractor at Bullfinch or Southern Cross (route dependant)


Combination of FIFO and DIDO workforce utilising;

Windarling airstrip and camp for mining personnel

Accommodation and haulage depot in Bullfinch or Southern Cross for haulage contractor personnel

The preferred cartage contractor will be in attendance at the meeting, and it is envisaged that the following combinations will be used:

Heavy Vehicle Services (HVS) has received a 42m A Triple Performance Based Standard (PBS) Scheme Vehicle Access Approval application, requesting AMMS Level 3 Mass (23.5t for tri axle groups).



Proposal

Long haulage distance necessitates the use of roadtrains

Proposing RAV Network 7 / PBS Tri Drive AMMS 3 approved roadtrains (triples) -42m total length and 98 tonnes/load

This configuration results in 1.5 loads per 12hr shift per truck –hence haulage depot location

Proposing haulage of approximately 55,000 to 60,000 tonnes per month for up to 26 months

Day and night shift trucking operation –day shift only doesn't work

Average -20 to 22 truck loads per day (i.e. one way)

Bullfinch – Edna May Options

Warralakin Rd Option (Bitumen):

- All Westonia Shire roads, all bitumised, 3 x intersection upgrades, Stoneman/Boundary challenging
- Route undergoing MRWA HVO assessment

Southern Cross Option (Bitumen):

- Yilgarn intersection upgrade and 1x MRWA intersection upgrade (maybe, costly, long lead time)
- Longest route -highest cost/less preferred
- Route under MRWA HVO assessment

Warrachuppin Rd Option (Gravel):

- Westonia Shire Rd, farmhouses, continuous maintenance, shorter route (-18km compared to Warralakin)
- BoodarockinRd Option (Gravel):
- Westonia Shire road, no farmhouses, continuous maintenance, shortest route (-22km compared to Warralakin)

This will have an impact on Councils infrastructure and Council will need to monitor and charge accordingly.

The Chief Executive officer is currently discussing the proposal with the Shire of Yilgarn and Merredin to gauge a suitable cost for access to the route. It is envisaged that a similar cost arrangement to that held with Blue Cap Mining would be in place subject to this approval.


They are seeking your support for the following roads to be added to the following networks/ approved routes.

The other issue is that Ramelius Resources have requested AMMS level 3 for concessional loading along the route, of which Council has a policy of only granting AMMS Level 2 access to Shire Bitumen roads. The CEO has delegated authority to grant a higher AMMS Level on a case by case basis, but as this involves large truck movements over an extended period, that it be referred to Council for consideration.

Comment

The PBS scheme offers potential for heavy vehicle operators to achieve higher productivity and improved safety through innovative vehicle designs. There are many benefits in providing access for PBS vehicles. Some of these benefits include:

- Braking capability and vehicle stability is improved with a mandatory requirement in WA for Electronic Braking Systems (EBS) and Rollover Stability Systems (RSS), which is not a requirement on conventional road trains.
- PBS vehicles are often height restricted, which is determined by the PBS assessment which further reduces the rollover risk and improves overall stability.
- PBS vehicles are subject to stringent axle spacing requirements, reducing the impact on the road infrastructure
- PBS vehicles reduce the number of vehicle movements compared to conventional heavy vehicles which overall reduces congestion and the crash risk exposure.
