





### WORK SUPERVISOR'S REPORT

#### 1. PLANT REPAIRS & MAINTENANCE

- Significant plant repairs and maintenance carried out since the last meeting were.
  - New Freightliner Is currently in at Daimler Perth to have a new clutch/gearbox installed under warranty. This is very ordinary considering that the truck has only travelled 40,000kms.
  - Multipac Roller replace broken bolts fuel filter support.
  - HAMM Roller replace air-conditioner bolts and bracket.
  - Mitsubishi Canter 60,000km service.
  - Toyota Ute (Grader) 60,000km service.
  - Toyota Ute (Trucks) 80,000km service.
  - Cat Grader reseal leaking steer cylinder fitting and repair airconditioner.
  - Go-Go Mobile installation of new fan and shroud repaired and fabricated by Karni Engineering.
- I have attached a report with the plant operation costs for all major machines for the 20/21 financial year for Council information. (Refer Attachment)

#### 2. <u>CAPITAL ROAD WORKS</u>

- Limited Capital works have been carried out during the month due to inclement weather conditions, but gravel cartage has commenced on the Maxfield Road project, and gravel construction of footpaths has been carried out on Wolfram, Pyrites and Scheelite Streets.





# Strengthening Telecommunications Against Natural Disasters (STAND) Project

Local Governments were invited in March to apply for the provision of NBN fixed satellite services to facilities such as community evacuation centres, community halls or Local Government offices as part of the STAND Project.

WA submitted 141 applications from 79 Local Governments for the provision of this service. The Commonwealth has advised that all applications have been endorsed and are being assessed by NBN for installation suitability based on the data provided by Local Governments.

Installation dates have not been established but are expected to occur in the December quarter ahead of the coming bushfire and cyclone periods.

This capability is designed to provide internet access and the ability to make phone calls for 40 community members concurrently using the service during emergency events.

### **Regional Air Services**

A sample of residents in 21 regional towns that have direct flights to and from Perth will receive a letter inviting them to participate in a 10 to 15-minute online survey about air travel and airfares.

This survey being undertaken by the Department of Transport is an important opportunity to encourage residents to actively participate in shaping the future of regional air services.

Local Government efforts to improve the availability and affordability of regional air services have been actively supported by WALGA including through:

- submissions to the Aviation Strategy review in mid-2020
- submissions to and an appearance before the Economics and Industry Standing Committee Inquiry into Regional Airfares in 2017, and
- submissions to the mid-term review of regulated RPT routes in 2014 and 2015.

Although COVID-19 related travel restrictions have impacted regional air services, there have been some positive improvements to services and airfares, particularly on regulated air routes.

Local Governments across regional WA identify that affordable and available air services are important to stimulate tourism, other economic activity as well as ensure access for residents to essential medical and other services. Councils in towns with regional air services could consider using their communications channels to encourage residents to participate in the survey.

# Bushfire Operations Committee Communique



#### Meeting date : 14 July 2021 Location: Bushfire Centre of Excellence, Nambeelup

The BOC members were guided on a tour of the new facility by Bushfire Centre of Excellence Chief Superintendent, John Tillman.

#### DISCUSSION ON CHAIR NOMINATION

Members have been advised that BOC Chair Greg Day has stepped down from his position on the ROAC and consequently, the BOC. Nominations and election of the new BOC Chair will occur out of session.

#### CORPORATE SERVICES UPDATES

Presentation by DFES Executive Director Corporate Services Richard Burnell.

#### **Telecommunications resilience improvement (STAND Project)**

141 applications from 79 Local Governments have been received for STAND Emergency NBN Satellite WiFi Services and progressed to the Commonwealth for approval. All applications have been endorsed by the Commonwealth and planning for installation ahead of the coming cyclone and fire seasons has commenced.

DFES have formed a multi-organisational telecommunications resilience improvement working group with representatives from DPIRD, WALGA, Telstra, TPG, NBN, Optus, Western Power, Horizon Power with oversight of the STAND project and treatment options and meets on a fortnightly basis. Current priority is defining priority locations for second round of STAND MNHP battery upgrade funding. The working group will also progress with analysis and planning for standalone and standby power solutions to treat the remaining base stations in high risk areas.

#### Water Tanks

Local Governments have applied for Water Tanks from Round 2 funding. Applications will be considered at the next LGGS Capital Grants Committee meeting to be held 4<sup>th</sup> August. LGs will be advised once the Committee has finalised their decision.

#### **Bushfire Awareness Campaign and App**

An update was provided on the My Bushfire Plan app and Fireproof Campaign including some key information based on the evaluation. There was a considerable increase in awareness and the number of bushfire plans developed following the bushfire campaign.

#### Workplace Health & Safety Legislation

An update was provided on the new Workplace Health & Safety Legislation. WALGA are working with LGIS to deliver a webinar for LG CEOs on the new Workplace Health and Safety Legislation, what the legislation involves and how to minimise their risk. Noted that DFES SOPs are available for adoption.

#### Harvest and Vehicle Movement Ban

Options for providing advice to utilities during Harvest and Vehicle Movement Bans was discussed. The BOC agreed upon using local contact list for utilities to undertake work during Harvest and Vehicle Movement Bans.

#### Presentation by DFES Deputy Commissioner Craig Waters.

A summary of the safety issues identified on Light Tankers by Worksafe. Improvement notices were addressed through risk assessments and procedures were developed to address the issues.

#### DOAC ROAC COMMON & SIGNIFICANT ISSUES

Presentation by WALGA Manager Resilient Communities, Susie Moir.

#### Legal implications relating to existing running fires and TFBs.

DFES Legal advise, DFES require that reasonable steps are taken to put the fire out or otherwise monitor the fire. DFES cannot comment on the loss of Insurance or civil liability in the event of an escaped burn.

**Issues relating to weight and licence restrictions on trucks.** This issue related to light and heavy in general being at the top end of licensing capability. Concessional licensing is a solution, but LGs carry the risk.

**Decommissioned vehicles with damaged and cut hoses and wires. Flashing lights aren't permitted and are removed.** Once an appliance is determined as beyond economical or serviceable life, the appliance is decommissioned (all lights, sirens, signage removed) and deregistered. All other items that can be reused or repurposed are also removed. The appliance is then sold via a public auction 'as is', unequipped and unlicensed. The current process ensures the best return on investment.

**Progress update on Section 33 templates.** OBRM are currently developing a draft Section 33 template and guidance notes. OBRM will present the template and guidance notes at the next BOC meeting for their comment, prior to finalising for publication.

**Insurance cover for deployed volunteers – interstate/intrastate.** LGIS cover all volunteers on intrastate deployments. Volunteers travelling interstate are covered by state insurance through DFES.

**Training requirement for LGs on ESL budget**. Because of staff turnover, some LGs are not familiar with the ESL budget process. DFES is looking at alternative messaging to augment the existing face to face awareness and education meetings, including providing an induction pack and Webinar.

#### UPDATES FROM PREVIOUS KEY MEETING ACTIONS AND OTHER BUSINESS

**Replacement vehicles delivery schedules**, and the opportunity to investigate repurposing of out of tender vehicles within brigades was tabled. DFES advise that vehicle manufacturers lead times have been extended (in some cases to 12 months) on cab chassis' due to COVID factory shut downs and a worldwide shortage of engine control chips. The SES and BFS Capital Grants Committees will meet in early August and assess and approve the current replacement schedule and funding. Once finalised, local governments will be informed of the approved replacements and the planned delivery schedule. DFES is currently negotiating with vehicle distributors in Australia to address extended delivery lead times. There may be some consultation with LGs with options for alternate cab chassis'. High fire fleet vehicles are used to fill gaps in brigades as a risk mitigation action, which is managed through an operational risk review each year. Appliances that are replaced are assessed for the high fire fleet, there are currently 160 vehicles which are cycled through.

Query on changes to funding of the **CESM program**, noting the importance of CESMs in local government. DFES advise the CESM pay structure is being standardised. CESMs are critical to the smooth running between local government and DFES, and a CESM coordinator has recently been appointed as a DFES point of contact for CESMs which will streamline communications.

#### CONTACTS

Query the process for booking **Automated Weather Stations** following the presentation by Bushfire Technical Services at the BOC March meeting. DFES advise there are currently five weather stations with a couple more on order. Local governments can request portable weather stations through their region and once approved will be deployed if available. During an incident portable weather stations can be requested by the RDC through WebEOC.

Query with the fires in the US and Canada, and if there was any word on **international deployments**. DFES advised that a request had been received through the National Resourcing Centre and AFAC are coordinating a response on behalf of the EMA to determine what resourcing jurisdictions will provide.

Query on **COVID management** during incidents and confirmation that the direction is through the ROC to invoke the COVID clause. DFES advised that this is dependent on the State Government directions at the time, however COVID is a consideration during all incidents, especially level 3s, where a COVID officer will be online to ensure compliance with requirements.

The next BOC meeting is scheduled for October and will be held at the new Koolinup ESC in Collie.
