# **CEO'S REPORT**

# GENERAL MATTERS

- MRWA has updated the Council's RAMM road data with the recent revaluation of Council's
  infrastructure assets. This has seen an extra 56.5km of sealed roads included in the data which will
  have a knock-on effect to future grant funding from the Grants Commission in the future.
- During the month I attended the Westonia Fire Brigade meeting but was an apology for the Advisory Committee meeting due to being in Perth for LG Week.
- I attended LG Week with fellow Councillors from the 8 to 11 October.
- The Tidy Towns judging too place on Wednesday 25<sup>th</sup> September. Both judges were suitably impressed, and we have since been notified that Westonia is a finalist in two of the three categories nominated. The awards event is being held on Friday 29<sup>th</sup> November.
- Jim Pascov has moved into unit 3 of the Pyrite Street units.
- Mort Wignell, Council's EHO, attended Westonia on Wednesday 9<sup>th</sup> October where he has again issued a notice to the Carrabin Roadhouse to complete the repairs to the men's ablutions, various kitchen upgrades and general clean-up of yard surrounds from grasses to reduce vermin and fire risk. They have 28 days to comply.
- The Pool Kiosk project is progressing well with all finishes and materials being sourced, verandah ceilings being installed, glazier soon to fit all windows and doors.
- The Westonia Progress Association Fuel Depot is working extremely well and is a great addition to the town. From its opening 7 September 23 until the 1 October 24 the depot has sold 179,000L Diesel and 21,000L ULP.
- With the assistance of Shire President Mark Crees and the generous donation from John & Jackie Cheeseman Council has acquired a Linton Seed Grader/Pickler which is being displayed with the other old farm equipment in the main street.



• Also a generous donation from Bob & Joyce Hood-Penn the Caravan Park now has 4 x pushbikes that will be freely available to ride around town by visitors to the Park.



- I met with Mr Alex Mckenzie, WDC, on Thursday 17<sup>th</sup> October to discuss Land and Housing constraints/future plans for Westonia moving forward.
- I conducted a HCS medical trip to Perth for a client on Monday 21st October.
- Assisted new residents located on Lot 109 Jasper Street to have their Water connection to the new house instigated.
- The CEO car suffered some panel damage from a kangaroo strike on Tuesday 15<sup>th</sup> October. A insurance claim has been lodged.
- The Warm Water Pool project is still being engineered with plans likely in the next couple of weeks.
   As the planning process has dragged on for some time now we have missed our window of opportunity with the pool installers who have committed to another project until about April 2025.
   This will all fit in with the other upgrade works proposed for the site anyway.
- The Warralakin Tank restoration project has progressed well with the stage 1 removal of old roof being completed. The second stage concrete treatment process will commence on 12 November, whereby they will address the small leakages on the Egg Rock Tank at the same time. The Hexa Cover products have also been ordered and will arrive in the next few weeks for installation.


- Various minor repairs and maintenance ongoing. Focal area being bathroom maintenance (fixtures and disabled bathroom upgrade)

# Joint media statement - Upgrades continue on Great Eastern Highway

Safety upgrades to the Great Eastern Highway are continuing with a \$23 million contract awarded for works in the Wheatbelt Region.

Safety upgrades to the Great Eastern Highway are continuing with a \$23 million contract awarded for works in the Wheatbelt Region.

The upgrades form part of the Australian and Western Australian Government's \$250 million Great Eastern Highway Upgrades, delivering improvements to various sections of the highway through the Wheatbelt and Goldfields-Esperance Regions.

Fulton Hogan received the contract to deliver three sections of road reconstructions, widenings and sealings including:

- 4.4km between Carrabin and Bodallin
- 4.6km between Nulla Nulla South Road and approximately 700m west of Liddell Road (west of Moorine Rock)
- 2.4km between Liddell Road and Granich Road (west of Moorine Rock)

The project also includes upgrades to the intersections of Great Eastern Highway with Smyth Road, Nulla Nulla North Road, Bin Road and Granich Road and the installation of new safety barriers, kerbs, signs and audible edge and wide centre line road markings.

The upgrades follow the completion of major works on the highway including:

- Widening and sealing between Stephen Road and Noongar South Road
- Realignment through the Bodallin townsite
- Intersection upgrades at Penton Road, Ivey Road, Blyth Road, Bodallin South Road and Bodallin North Road
- Construction of an eastbound passing lane between Bodallin and Moorine Rock
- Construction of a westbound rest area between Bodallin and Moorine Rock

The works funded under the \$23 million contract are expected to be completed in late 2025 with the staged upgrade program continuing along the highway until 2028.

The second is a photo of two businesses with people standing out the front. One of the businesses is mentioned in the cash book. It is in very good condition. I have included some photos below.


I was just wondering if this is something the Historical Society would be interested in? I would be happy to try and get it to you somehow. I live in Perth.

### 2024-25 FINAL FINANCIAL ASSISTANCE GRANT ALLOCATIONS

The WA Local Government Grants Commission (**Commission**) has been advised by the Commonwealth Minister for Local Government, the Hon Kristy McBain MP, that the 2024-25 Commonwealth Financial Assistance Grants (**FA Grants**) have been formally approved.

In 2024-25, Western Australia's share of the final funding pool available for distribution is \$400,032,981 (includes adjustment for 2023-24). Of this \$245,557,008 is General Purpose funding (\$208,757,650 paid in advance in June 2024) and \$154,475,973 is Local Road funding (\$130,658,557 paid in advance in June 2024).

In 2024-25, 32 local governments received the minimum grant general purpose grant allocation. The remaining general purpose grant funding pool allowed for 68.8 per cent of calculated grant need to be paid to the remaining local governments.

# Financial Impact of Advance Payments in 2023-24 and 2024-25

In June 2023, the Commonwealth Government decided to make a 100 per cent advanced payment of the estimated entitlement as calculated at that point in time. This then led to very limited quarterly payments being made throughout the 2023-24 financial year. The decision made by the Commonwealth Government was to provide an immediate boost to local government cash reserves to help manage the cumulative impacts of the COVID-19 pandemic and recent natural disasters.

The allocation to local governments from the Commonwealth was based on grant recommendations from the previous year (2022-23) with indexation in line with the growth to the grant allocation to Western Australia. However, the Commission's methodology allocates funding not purely based on indexation of the grant pool but based on a variety of factors to ensure equitable distribution in accordance with the legislation that is appropriate for the State. Therefore, the 100 per cent advance payment in 2023-24 created Over and Under payments for every local government in Western Australia.

For many local governments, the Commission identified that the difference was likely to be very small, and not having a material impact on the local governments budget. Other local governments, however, needed to consider the likely impact on their 2024-25 FA Grant funding. Written notifications were sent out to the affected local governments that met the threshold of a variance of greater than \$50,000, or less than \$50,000 but greater than 2 per cent of the rates revenue.

As you may be aware, the Commonwealth Government announced there will be an advance payment of the 2024-25 FA Grants to all jurisdictions nationally, it was advised that the funds are were being paid early to help councils facing immediate cash flow pressures, ensuring they can continue to deliver for their communities.

In June 2024, an advance payment of 85 per cent of the estimated 2024-25 entitlement was paid to the local governments, as calculated at that point in time. This again resulted in limited capacity to make quarterly payments to local governments. This year the remaining quarterly payments came to a total of \$60,616,774.

The Commission faced some challenges this year, the most impactful was the compounding issues caused by the 100 per cent advanced payment (over and under payment) of the 2023-24 FA Grants and a negative adjustment from the 2023-24 FY.

While the Commission intended to redistribute all of the over and under payments caused by the 100 per cent advance payment (over and under payments) of the 2023-24 FA Grants, unfortunately this was not possible due to the operation of the *Local Government (Financial Assistance) Act 1995* (Cth), it is hoped the redistribution of these funds will be completed by the 2025-26 FA Grants. The Commission will continue to communicate with affected local governments throughout this process.

Additionally, Western Australia also had a negative adjustment of approximately (-\$500,000) in the current allocation from the final 2023-24 allocation. Due to the negative adjustment, the minimum grant principle and the remaining funds being limited (approximately 15 per cent of the funding pool), variances of the over and under payments occurred.

The Commission has identified the Shire of Westonia was overpaid by \$15,446.00 for their 2023-24 FA Grant entitlement. This has resulted in the Shire 's FA Grant allocation to be reduced by approximately this amount in the 2024-25 allocation as well as taking into account additional balancing adjustments.

# **Quarterly Payments to Local Governments**

The first quarterly payment was made on 16 August 2024. The remaining three quarterly payments are expected to be deposited in the middle of November, February and May of the 2024-25 financial year.

# **Payments of Special Projects Grants**

Payment of Special Project allocations will be included with the four quarterly payments of the General Purpose Grants and Local Road Grants.

Main Roads WA contributes \$1 for every \$2 allocated to Special Projects by the Commission. This contribution is made on the condition that the Special Project funds are spent on the project to which the funds have been allocated. Your local government should consult Main Roads before commencing work.

Please ensure that proper records of these grants are kept for your local government's annual audit at the end of the financial year. # **Special Project Grants - Aboriginal Access Roads**

The Commission has allocated \$3,586,333 of Commonwealth road funds for the improvement of local government access roads to remote Aboriginal Communities as part of its Special Project funding program.

The allocations have been based on advice from the Aboriginal Roads Committee, which includes representatives of the WA Local Government Association, Main Roads WA, Department of Planning, Lands and Heritage (formerly Department of Aboriginal Affairs), Department of Local Government, Sport and Cultural Industries and the Commonwealth Department of Prime Minister and Cabinet.

The Aboriginal Roads Committee has been advised that some Aboriginal Communities are concerned that road works are often carried out without proper consultation with them. It should be understood that the Special Project grants are made on the premise that local governments consult with Aboriginal Communities before decisions are made on road works.

Please note that the Special Project funds are allocated for road improvements and re-sheeting gravel roads, not routine maintenance. Provision for maintenance is made through the Commonwealth road funds allocated in accordance with asset preservation needs.

# **Special Project Grants - Bridges**

The Commission has allocated \$7,172,667 of Commonwealth road funds for the preservation of bridges on local government roads as part of its Special Project funding program.

The allocations have been based on advice from the Bridge Committee, which includes representatives of the WA Local Government Association and Main Roads WA.

The Commission is highly aware of the impacts and unpredictability that the advance payments have created and is working to identify how any variance in the future allocations can be prevented or reduced.

Of course, the long-term and annual budgeting forecast are subject to change and change impacts results reported in annual financial statements.

The Commission will continue to advocate for advance payments that do not impact on the financial sustainability of local governments and the normalisation and consistency in the advance distribution.

# LIVE EXPORT DOLLARS A SLAP IN THE FACE, DAVIES

16th October 2024

Member for Central Wheatbelt Mia Davies has slammed the Federal Labor Government's latest transition package offer for the live sheep export industry saying it was rubbing salt in the wounds of those impacted.

"If the Minister has shown up expecting bouquets for increasing the transition funding, she'll be disappointed," Ms Davies said.

"They either don't care or don't understand - we don't want funding, we want our industry to continue."

Ms Davies said she stood by the thousands of people and hundreds of businesses and livelihoods linked to the live sheep export industry.

"I stand by those farmers, truck drivers, shipping companies, livestock agents, veterinarians, port workers, shearers, feedlot businesses and all involved in the sector – no legitimate and ethical industry should ever be closed for political ideology, or to suit activist agendas," she said.

"Labor's decision is devastating, driven by the desire to appease animal activists and capture inner-city votes.

"The Albanese Labor Government is no friend of Western Australia."

Ms Davies said she'd never seen a less enthusiastic, muted and defeatist attitude than that shown by Minister Jacquie Jarvis and Premier Cook when standing up for West Australians on this issue.

"If they truly supported the industry, they would be on the front foot *every day* railing against this decision," she said.

"Instead, they shrug their shoulders and relinquish this important industry to a political hatchet job by their own Party and Prime Minister."

Ms Davies said industry and its leaders should demand more of their State Agriculture Minister, and WA should send a clear message to the Albanese Government at the polls at the next election.

"I am pleased that Federal Nationals Leader David Littleproud has committed to repealing the legislation as his first act in the Parliament should we be returned to Government," she said.

"Western Australia handed the Prime Minister the keys to the Lodge in Canberra and all we've had since is misery.

"Households are worse off financially and this Labor Government continues to pursue policy and legislation that makes it harder for agriculture, mining and small business to operate, the very sectors that underpin our State and national economy."

We apologise for the delay in responding to your initial query logged on 3 September 2024 under reference P7G4K0801433. I can confirm feedback has been forwarded to the appropriate

Western Power is currently experiencing a high volume of work which is ultimately affecting our delivery timeframes and distribution customer delivery expectations due to an increase from around 3500 applications per year to around 5500 applications. We are aware of the current situation being faced by our customers and have implemented several initiatives including working with external design vendors, actively recruiting specialists as part of the distribution design team to increase capability and output and publishing indicative timeframes on our website for varying connection requests to allow customers to plan their project and or construction schedules accordingly.

The current indicative timeframe (subject to change) is available to customers at the time of making their application and published on the Western Power website:

I can confirm your project is progressing in accordance with our published timeframes and is currently in the queue to be allocated to a designer and the design and quote will be sent to the nominated person for the project once completed.

Unfortunately, we are unable to meet your request to expedite your application. Western Power is committed to providing all customers with a fair and equitable service, therefore prioritising one project over another is not possible as it would unfairly impact customers and their projects further ahead of yours in the queue. The exception to this being hospitals, medical facilities, schools, and community housing which are reviewed case by case.

I apologise if we have not met your expectations to date and assure you, we will continue to work as quickly as possible to progress and complete not only your project, but all projects in our queue(s). # **Background**

WALGA have heard from many of our Member Councils that large scale renewable energy projects, and the impact they will have on local communities, is a growing concern. In response to this, WALGA developed three advocacy positions on the energy transition, which were recently approved at the September State Council meeting (items 6.16, 6.17, 6.18 in our Advocacy Manual here).

Many Local Governments, in particular in the regions, are keen to collaborate with one another when it comes to navigating renewable energy projects. The Large Scale Renewable Energy Projects Teams Group provides a forum for these conversations to take place.

# **Purpose**

To provide a forum for CEOs and Elected Members to collaborate and share knowledge around large scale renewable energy projects and how they are navigating conversations with energy proponents and their communities. The Teams Group provides a place to share any relevant documents and policies which may be of use to other Local Governments, as well as a place for WALGA to share updates on the renewable energy work they have been undertaking.

The Group is focussed on large-scale renewable energy projects, including wind, solar, battery storage, hydrogen and transmission lines. Critical minerals and gas are out of scope for this group.

# Membership

Membership of the Teams Group is open to CEOs and Elected Members of WA Local Governments. In the first instance there will be a maximum of two people per Local Government admitted to the Group.




# **Guide for Joining the Microsoft Teams Group**

- 4. Once you have selected WALGA, you will switch to our organisation and the Large Scale Renewable Energy Project Teams Group will be visible.




