



#### Fire Breaks Order

responsibilities Council has under the Bush Fires Act 1954 to ensure that landowners have cleared fire breaks and removed flammable materials from their land according the to instructions outlined in the **Break** Shire's annual Fire Orders.

The requirements of the Orders are considered the minimum standard for fire prevention not only to protect individual properties but the district in general.

The requirements of the Orders are in addition to and do not detract from any other requirement under any other written law or legislation.

Fire Break Orders will be distributed with the annual rates notices to rate payers which will occur in July 2021

All rate payers are reminded NOT TO THROW AWAY there Fire Break Orders. Rate payers should keep the Orders in a safe place and ensure that they review the Orders to see what requirements are necessary to ensure their property is adequately prepared for the bushfire season which will commence from 1 November 2021.

All rate payers should note that where their property has been found to be in breach of the requirements of the Fire Break Orders (inspections are carried out by the Shire annually) then they may be issued an infringement.

## Roadworks update



The construction crew have been frustrated with the continual wet conditions but have nearly completed the gravel re-sheeting job on a section of Rabbit Proof Fence Road between Leeman & Lane Roads.
